# Commissioner Ameermia presents on climate change in Morocco

On 6 November 2016, the Acting Chairperson of the South African Human Rights Commission, Commissioner Mohamed Shafie Ameermia presented on the role of National Human Rights Institutions (NHRIs) on the climate change agenda. This was a meeting of representatives from NHRIs from across all regions including experts from the United Nations and civil society organisations, to discuss how NHRIs can work to strengthen linkages between the sustainable development, climate change, and human rights.

The meeting was convened as side event on the eve of the 22nd Conference of State Parties under the UN Framework Convention on Climate Change (COP 22).

Making a contribution during one of the panel discussions, Commissioner Ameermia said that "National Human Rights Institutions are crucial cogs in providing remedies to both individual and systematic human rights violations, particularly human rights

violations resulting from the adverse impacts of climate change".

The event was co-organised by the National Council for Human Rights of Morocco (CNDH), the Global Alliance of National Human Rights Institutions (GANHRI), the National Consultative Commission of France, the United Nations Office of the High Commissioner for Human Rights, and the Association of Francophone Human Rights Commissions, and with the financial support from the European Union.

# SAHRC accepts commitment to values of the Constitution after offensive social media posts

In October 2016, the South African Human Rights Commission (the Commission) was alerted through media reports of a social media post from Mr Tlou Molele, a mathematics teacher at Northern Academy in Polokwane in which he stated, amongst others that white people will "die inferior" and are "Genetic errors".

During a meeting convened by the SAHRC to discuss the racist social media post, Mr Tlou Molele expressed deep remorse for the posts. Noting the high number of posts of this nature, and the need to eradicate the fault lines premised on prejudice in society, the Commission was of the view that penal sanctions were not in themselves an adequate measure for promoting respect for the Constitution. The Commission stressed the values of the Constitution over and above the statutory protections our law offers, and impressed on the need to respect dignity, equality and freedom of people. # SAHRC host stakeholders to discuss budget for advancing Socio-Economic Rights roundtable

On 17 November 2016, the South African Human Rights Commission (SAHRC), in partnership with the Studies in Poverty and Inequality Institute (SPII), hosted a roundtable discussion on budget analysis for advancing socio-economic rights.

The roundtable event was held to assess whether government is progressively realising socio-economic rights within its available resources as required by the Contitution. The evcent was held at the backdrop of frequent claims that government does not have sufficient resources to meet these obligations. Futhermore to understand how government's budget operates, and how resources are prioritised to challenge these claims to ensure that access to housing, education, health care services and social security, among others, continues to be expanded and inequalities in the enjoyment of these rights are reduced. In addition to the constitutional obligations on the state to realise socio-economic rights, government is also required to do so in terms of the UN International Covenant on Economic, Social and Cultural Rights, which South Africa ratified last year.

# Political Parties Lodge New Hate Speech Complaint Against Malema

Some political parties and individuals have lodged a fresh hate speech complaint with the SAHRC against EFF leader Julius Malema. This move was taken after the EFF leader publicly stuck his neck out and said whites should not be slaughtered "for now".

Juju made this statement on Monday, November 7, shortly after he left the Newcastle Magistrate's Court. The complainants of the new hate speech include the former national spokesperson for the Congress of the People Youth Movement (Cope YM), Elias Muller, the Democratic Alliance and AfriForum, along with others from different provinces.

In their separate complaints, they expressed fear that Malema might be a threat to the white race in the near future. Muller described Malema's comments as reckless, irresponsible and shocking, considering the fact that he is a leader of a political party. "...I request the SAHRC to investigate Mr. Malema's statement of 'not calling for the slaughter of white people, at least not for now' because this suggests that there will be a time when Mr. Malema might call for the slaughtering of white people," Muller said in his complaint.

Confirming the development, SAHRC communications coordinator Gushwell Brooks admitted the organization has received fresh complaints from individuals and some political parties. "..The commission has received complaints from different provincial offices, these complaints are currently being assessed," said Brooks.




