Chairperson of the South African Human Rights Commission, Adv. Bongani Majola, delivered the Keynote address on *Transformation at Universities* at the Launch of the Free State Centre for Human Rights on 14 March 2017. The centre was formed following the widely reported incident, involving black cleaners who were humiliated by four white students in an initiation-type ceremony, in 2007. The centre is a result of one of the clauses of the settlement agreement between the SAHRC, workers, Reitz 4 students and the University. The other clauses; public apology, compensation, and a reconciliation ceremony have already been complied with.

Mohodi FM wins Community Radio Awards competition for defending the rights of listeners.

The South African Human Rights Commission (SAHRC) and the Office of the High Commissioner for Human Rights (OHCHR) held the Community Radio Award ceremony on 29 March 2017 to honour community radio stations that heed the call

from the two human rights bodies to *'stand up for someone's rights'*. Mohodi FM, a community radio station from Molemole in Limpopo won the ultimate award, a Hewlett Packard Laptop, with runner-up Inanda 88.4 FM from Kwa-Mashu in KwaZulu-Natal winning a Samsung 9 inch tablet and second runner-up Vaaltar News from Taung in the North West receiving a 7 inch Samsung tablet.

Community Radio stations entered the competition by sending news/current affairs programme clips where they defended the rights of a listener/s. Provincial finalists were subsequently chosen through a vigorous process. Subsequently, the three finalists were selected. Commissioner Angie Makwetla echoed Commissioner Jonas Ben Sibanyoni that "Community Radio stations are a good platform to disseminate human rights awareness information."

The event which coincided with Human Rights Month activities also honoured provincial finalists with certificates as a token of appreciation and recorders to enable them to record news interviews efficiently and continue to make a difference in the lives of their communities.

'Qwelane a delinquent who disrespects the Constitution,' human rights commission tells court

Former journalist and ambassador to Uganda Jon Qwelane's absence from his hate speech court case indicates delinquency and disrespect for the Constitution.

This was among the submissions made by the South African Human Rights Commission when it made closing arguments in the matter on Tuesday at the High Court in Johannesburg.

Qwelane has not attended the hearing, dealing with homophobic views he expressed in a 2008 newspaper column, since its commencement last week, after he collapsed in a shopping mall and was hospitalised. Source: Times Media, [Read more](#).

Equality remains one of the most violated rights in SA - SAHRC

The right to equality remains one of the rights most violated in South Africa. This is according to South African Human Rights Commission (SAHRC) Spokesperson, Gail Smith. March marks Human Rights Month in South Africa with the focus on human rights issues.

“Since 2012, the number one human right violation in South Africa has been around the right to equality. So, that remains the right we go to court on the most as the South African Human Rights Commission ... specifically those cases (which) would involve the use of the "K" word and other derogatory comments with racial undertones such as the use of terms baboon or monkey. So, it is the right to equality that is a top right, followed by labour disputes. We get a lot of labour disputes, most of those we send to the CCMA because they are another body that is setup to deal with specific labour rights and the third top right we deal with is around access to health care services, water, food and social security.” Source: SABC

POLOKWANE – The Limpopo Department of Education was recently ordered by the Seshego Equality Court to pay R60 000 in personal compensation to Nare Mphela, a transgender woman from Moletjie, Ga-Matlala. The case was brought to the court by the South African Human Rights Commission (SAHRC) last year on 14 November after there were allegations of humiliation and harassment based on the gender identity of the learner. SAHRC requests urgent meeting with Minister Dlamini over social grants

The South African Human Rights Commission (SAHRC) on Friday said it had requested an urgent meeting with Social Development Minister Bathabile Dlamini to discuss the lack of clarity on the payment of social grants.

There are heightened fears around the payment of social grants, as the current contract with Cash Paymaster Services (CPS) ends this month. No new arrangements have been finalised to pay social grants in April to 17 million recipients.

In a statement issued by spokesperson Gail Smith said the SAHRC said it has “requested an urgent meeting” with Dlamini and Thokozani Magwaza, the chief executive officer of the South African Social Security Agency (Sassa), to discuss the lack of clarity on the payment of social grants. HUMAN RIGHTS DAYS

Freedom Day, 27 April

Freedom Day is celebrated annually on 27 April. It celebrates freedom and commemorates the first post-apartheid elections held on that day in 1994. The elections were the first non-racial national elections where everyone over 18 from any race group, including foreign citizens permanently resident in South Africa, was allowed to vote. Previously, under the apartheid regime, non-whites had only limited rights to vote.
